3. Product description and application:

Textile-reinforced PVC garden hose designed for pressure transmission of fluids, including foodstuffs, according to Reg. (EU) 10/2011, simulant A.

4. Storage conditions:

To be stored at -20°C to +60°C.

5. Regulations and directives:

- Commission Regulation (EU) No 10/2011 of 14 January 2011 on plastic materials and articles intended to come into contact with food as amended by Commission Regulation (EU) No 1282/2011 of 28 November 2011 amending and correcting Commission Regulation (EU) No 10/2011 on plastic materials and articles intended to come into contact with food.
- Regulation (EC) No 1935/2004 of the European Parliament and of the Council of 27 October 2004 on materials and articles intended to come into contact with food.
- Commission Regulation (EU) No 1895/2005 of 18 November 2005 on the restriction of use of certain epoxy derivatives in materials and articles intended to come into contact with food.
- Commission Directive 2002/72/EC relating to plastic materials and articles intended to come into contact with foodstuffs, as stipulated by 2004/1/EC, 2004/19/EC, 2005/79/EC, 2007/19/EC, and 2008/39/EC.
- Regulation (EC) 2023/2006 on good manufacturing practice for materials and articles intended to come into contact with food.

6. Testing conditions:

Tested in long-term contact (24 hours) at 60° C using foodstuff simulants as shown in the table below, with contact surface of 100 ml/1 dm² or 60 mg/kg.
